## 1. Vector Disease Control – Mosquito Report

Mayor Jones informed the council that there was no report to review for this month.

#### 2. ADA Service Animal Law

Mayor Jones discussed the ADA Service Animal Law with the council. Jones stated that this law is relevant for many reasons, one of them being the recent bad weather, where residents utilized the storm shelter facility several times in one week. Jones explained that none of the residents brought in a service animal, however, one tried to bring an emotional support animal. Jones explained that, according to the law, those are not the same thing. Jones explained that service animals will be allowed to enter, however, emotional support animals will not. Councilmembers Shipman and Gambill asked questions about the law. Jones answered and clarified for both. Officer Wade Shapp, Brookland Code Enforcement Officer, explained some of the specifics of the ADA Service Animal Law for the council to understand. Attorney Kevin Orr presented a question he had received about separating people and animals into the storm cellar. Orr explained that creating a physical separation was not allowed by law for those with service animals, meaning you could not have a separate section for those who have a service animal.
