New Business:

1. Vector Disease Control – Mosquito Report:

Mayor Jones presented the council with the mosquito report received by Vector Disease Control.

2. Witcher Auctions Sale – Massey Ferguson tractor reserve was \$22,000; final bid was \$19,250:

Mayor Jones discussed the sale of the 2012 Massey Ferguson tractor through Witcher Auctions. Jones told the council that the reserve bid was set at \$22,000, which came about through a trade-in valuation received on the tractor. Jones notified the council that the final bid received was \$19,250.

Old Business:

1. Sportsplex – Discuss bid and options:

Mayor Jones discussed with the council the latest bid received for the sportsplex project. Jones reminded the council that he felt several components of the latest bid were inflated, when compared to the original bid.

Discussion: Wilson Shipman asked about redoing the bid at a later date. Mayor Jones indicated that the city has begun the process of applying for the Community Assistance Grant and will hopefully receive more funding in order to complete the sportsplex project. Jones stated that if more funding is received, the project can be completed closer to the original plan, with 5 fields, a walking track, fishing pond, concession stand, and parking. Jones added that the only thing that should not be included from the original plan is lighting for the 2 small fields.
